**Priests who served in the Diocese of Lafayette-in-Indiana with
Substantiated Allegations of Sexual Misconduct with Minors**

Originally Released September 28, 2018

In the September 16, 2018 edition of The Catholic Moment, Bishop Timothy Doherty committed to publishing a list of clergy with substantiated allegations of sexual misconduct with minors who served in the Diocese of Lafayette-in-Indiana. Today, September 28, we are publishing this list and making a commitment to provide updates to the list so that it remains current.

The following clergy that served in the Diocese of Lafayette-in-Indiana, had a substantiated allegation of sexual misconduct with a minor, and as a result, are no longer in public ministry. When considering this list, please bear in mind the following points:

- Our primary concern in the publication of this list is for the benefit of the victims. That the victims know the person who abused them has been identified, and the name(s) of the abuser(s) made public.
- If you have been a victim of abuse by clergy, or know someone who has been, please contact the following:

- Abuse may take different forms that constitute an attack on the person's emotional and physical being.
- Allegations are deemed to be substantiated when there is reasonable cause to believe that abuse with a minor occurred. A determination does not constitute a legal judgement.
- This list covers the period from 1944 (the year the Diocese of Lafayette-in-Indiana was created) to the present.
- Cases reported subsequent to 1994 (when the Diocesan Review Board was created) have been presented to the DRB for review and recommendation.

- Cases predating 1994 were reviewed using Diocesan administrative processes.
- *The Catholic Moment*, the newspaper of the Diocese of Lafayette-in-Indiana has, as a matter of practice, posted announcements about the removal of clergy from ministry for sexual misconduct with minors.
- Secular newspapers, through investigative reporting, have provided the public with the names of clergy serving in the Diocese of Lafayette-in-Indiana who were accused of child sexual abuse. In particular, we reference:
