NARRATIVE  
 on 02-09-07 at 1500 hours, subject #1 walked into the lobby of the Metro Patrol Division to report a rape that had occurred in December of 1952.  
 Subject #1 stated that in June of 1952 Subject #2 befriended Subject #1 while he was a Priest and associate Director of St. James Catholic Church. (3939 Harrison Kansas City MO)  
 Subject #2 started taking Subject #1 out to basketball games, to eat ice cream and other social events.  
 Subject #1 who was 15 years of age at the time did not think of it as romantic in nature.  
 In December of 1952 subject #1 and subject #2 went to a Christmas party together.  
 Subject #2 put some Rum or other alcohol into subject #1's drink.  
 Subject #1 became intoxicated and passed out. When she awoke she was in subject #2's vehicle without any clothes on. She observed subject #2 to be crying and very apologetic saying he was sorry. Subject #2 stated that "God had sent subject #1 to him as her chosen love".  
 Subject #1 stated that subject #2 had vaginal intercourse with her while she was passed out.  
 Subject #1 further stated that subject #2 had vaginal intercourse with her on different occasions without her consent from December of 1952 to Spring of 1954.  
 (It should be noted subject #2 passed away in Las Vegas Nevada on 06-23-95)  
 Sgt. Matthews of Sex Crimes was notified.  
 Sgt. Blow was notified.
